This matter comes before the State Ethics Commission by virtue of a complaint filed by the Commission on October 17, 2013. On January 15, 2014, pursuant to S.C. Code Ann. § 8-13-320(10)(i)(Supp. 2013), the State Ethics Commission reviewed the above-captioned complaint charging Respondent, Cheryl Y. Glover, with a violation of Section 8-13-1308 and probable cause was found.

Present at the Hearing on July 16, 2014 were Commission Members, James I. Warren, III, Chair, James H. Burns, and Regina H. Lewis. Respondent was present and appeared *pro se*. Complainant was represented by Cathy L. Hazelwood, General Counsel. The following charge was considered:

COUNT ONE
FAILURE TO FILE A PRE-ELECTION CAMPAIGN DISCLOSURE REPORT
SECTION 8-13-1308(D), S.C. CODE ANN., 1976, AS AMENDED

That the Respondent, Cheryl Y. Glover, a candidate for Charleston County School Board, in a November 6, 2012 election, did in Richland County, on or about October 22, 2012, fail to timely file a pre-election Campaign Disclosure Report in violation of Section of 8-13-1308(D).

FINDINGS OF FACT

Having carefully reviewed the evidence presented, the Commission finds as fact:

1. The Respondent, Cheryl Y. Glover, was a candidate for Charleston County School Board, in a November 6, 2012 election.

2. Kristin Smith, administrative coordinator of the Commission's non-compliance office, testified that on March 20, 2013, Respondent filed an initial Campaign Disclosure form (CD) showing her election on November 6, 2012. On July 16, 2013 Respondent was assessed a \$100.00 late filing penalty for failure to file a pre-election CD by October 22, 2012. On August 7, 2013 the penalty letter was sent certified. The letter was delivered on August 9, 2013. Penalties began accruing at \$10 per day on August 19, 2013 and at \$100 per day on August 29, 2013. Respondent filed the pre-election CD on October 30, 2013. The late filing penalty of \$5,000.00 has not been paid.

3. Daniel Choate, State Ethics Commission Investigator, testified that on October 29, 2013 he contacted Respondent by telephone. She stated she would comply. On October 30, 2013 Respondent did file her late CD. The outstanding penalty remains at \$5,000.00.

4. Respondent, Cheryl Y. Glover, testified that Investigator Choate was helpful, although she did not know about the on-going increase in the late filing penalties. She was a write-in candidate for a Charleston County Constituent Services District #9 seat. She only had one flyer with a slate of candidates. The clerk was new and told her to file a Statement of Economic Interests and she did or she thought she did. Ms. Glover testified that she works with the state courts and she knows how important the timely filing of paperwork is, but she just didn't know what to file.



CONCLUSIONS OF LAW

Based upon the Findings of Fact, the Commission concludes, as a matter of law:

1. During all times relevant, the Respondent, Cheryl Y. Glover, was a candidate as defined by Section 8-13-1300(4).

2. The State Ethics Commission has personal and subject matter jurisdiction.

3. Section 8-13-1308(D) provides that a candidate must file a pre-election Campaign Disclosure form 15 days before the election.

4. Section 8-13-1510(1) provides as follows:

Except as otherwise specifically provided in this chapter, a person required to file a report or statement under this chapter who files a late statement or report or fails to file a required statement or report must be assessed a civil penalty as follows:

(1) a fine of one hundred dollars if not filed within five days after the established deadline provided by law in this chapter;

DECISION

NOW, THEREFORE, based on the foregoing Findings of Fact and Conclusions of Law, the State Ethics Commission has determined based upon a preponderance of evidence that Respondent Cheryl Y. Glover is in violation of Section 8-13-1308; and therefore, Respondent Cheryl Y. Glover is hereby assessed a late-filing penalty of \$2,500.00.

IT IS FURTHER ORDERED, pursuant to Section 8-13-320, a Judgment in the amount of \$2,500.00 is, and shall be entered against Respondent.

IT IS FURTHER THE ORDER OF THIS COMMISSION that the Clerk of Court of the County in which Respondent was last known to reside shall enter this Order in its Judgment Rolls, without cost to the State Ethics Commission, in the amount of \$2,500.00 upon the Commission's filing of same with the Clerk of Court's Office.



FINALLY, Respondent Cheryl Y. Glover has ten (10) days from receipt of this order to appeal this Decision and Order to the full Commission.
