Section 8-13-1308, S.C. Code Ann., 1976, as amended, requires candidates to file Campaign Disclosures within ten (10) days of receiving or expending \$500; fifteen (15) days prior to each election; within ten (10) days of the end of each quarter; and a final report when the campaign account is closed. In addition, certified campaign reports detailing campaign contributions and expenditures must contain the total of contributions accepted, the name and address of each person making a contribution, the total expenditures made by or on behalf of the candidate or committee, and the name and address of each person to whom an expenditure is made from campaign funds. Pursuant to Section 8-13-1362 and Regulation 52-504 (C), the Pre-Election and quarterly report are required even when there have been no contributions or expenditures.

Records of the State Ethics Commission indicate that a Pre-Election Campaign Disclosure was due no later between October 16, 2019 and October 21, 2019.

Respondent was reminded of the filing requirement by a certified letter dated October 3, 2022 as described in the attached. To date, a properly completed Pre-Election Campaign Disclosure has not been received. All in violation of Section 8-13-1308(A), Section 8-13-1308(D)(1), and Section 8-13-1308 (F), S.C. Code Ann., 1976, as amended.

If there is a finding of probable cause, the following documents become public record: the complaint, the response (if any) by respondent, and the notice of hearing. If a hearing is to be held, the final order and all exhibits become public record. If no hearing is held following a finding of probable cause, the final disposition of the matter becomes public record.

The following allegation will be heard:


COUNT ONE
FAILURE TO FILE A PRE-ELECTION CAMPAIGN DISCLOSURE REPORT
SECTION 8-13-1308(A), S.C. CODE ANN., 1976, AS AMENDED

That Travis Kennedy, candidate for Norris Town Council, did in Richland County, fail to file a 2019 Pre-Election Campaign Disclosure Report, in violation of Section 8-13-1308(A).

You have the right to be represented by counsel, the right to call and examine witnesses, the right to introduce exhibits, and the right to cross-examine opposing witnesses. This hearing will be open to the public as required by Section 8-13-320(10)(j), Code of Laws, South Carolina, 1976, as amended. The procedures to be followed are set forth in the Administrative Procedures

Act, Section 1-23-10, et seq., Code of Laws, South Carolina, 1976 as amended, the State Ethics Act, Section 8-13-100, et seq., Code of Laws, South Carolina, 1976, as amended, and State Ethics Commission Regulations, S.C. Code Ann. Regs. 52-707 (1997 Cum. Supp.).

A pre-hearing conference may be scheduled prior to the hearing to allow exchange of witness lists and evidence, marking of exhibits, and disposition of motions or pleadings. In the event you fail to appear, judgment by default will be rendered against you. 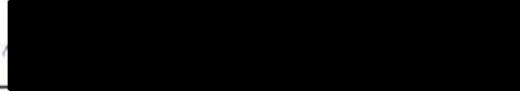

CONSENT ORDER

This matter comes before the State Ethics Commission (Commission) by way of a Complaint filed on May 24, 2023. Pursuant to Section 8-13-320(10)(i) of the South Carolina Ethics, Government Accountability, and Campaign Reform Act (Ethics Act), the complaint against William C. Beacham (Respondent) was considered by the Commission and probable cause was found to warrant an evidentiary hearing. Prior to the call of the case, Respondent agreed to the following:

STATEMENTS OF FACT

1. Respondent was an unsuccessful candidate for Norris Town Council in a November 5, 2019 election.
2. Respondent did not file a Pre-Election Campaign Disclosure Report (CDR) before the election.
3. In an October 3, 2022 certified letter, the Commission assessed a \$100 late-filing penalty against Respondent for his failure to timely file the 2019 Pre-Election CDR. According to the letter, additional late-filing penalties would accrue if Respondent failed to file the Pre-Election CDR within ten (10) days of his receipt of the letter.
4. According to the United States Postal Service (USPS), the certified letter was signed for by Respondent on October 6, 2022 at 12:52 p.m.
5. On October 16, 2022, penalties began to accrue at \$10 per day.

6. On October 26, penalties began to accrue at \$100 per day.
7. On April 28, 2023, Commission staff telephoned Respondent and scheduled an appointment with Non-Compliance staff for May 2, 2023 at 9:00 am for Respondent to receive assistance filing his Pre-Election CDR.
8. On May 2, 2023, Non-Compliance staff unsuccessfully attempted to contact Respondent twice.
9. Receiving no response from Respondent, the Complaint was filed on May 24, 2023.
10. On June 21, 2023, following contact from a Commission Investigator, Respondent filed his 2019 Pre-Election CDR disclosing no campaign contributions or expenditures.

CONCLUSIONS OF LAW

Based upon the Statements of Fact, the Commission concludes, as a matter of law:

1. At all times relevant, Respondent was a candidate pursuant to Section 8-13-1300(4).
Therefore, the Commission has personal and subject matter jurisdiction.
2. Section 8-13-1308(A) provides, in relevant part:

. . . a candidate who does not receive or expend campaign contributions totaling an accumulated aggregate of five hundred dollars or more must file an initial certified campaign report fifteen days before an election.
3. Section 8-13-1510(A) provides, in relevant part:

. . . a person required to file a report or statement under this chapter who files a late statement or report . . . must be assessed a civil penalty as follows: (1) a fine of one hundred dollars if the statement or report is not filed within five days after the established deadline provided by law in this chapter; and (2) after notice has been given by certified or registered mail that a required statement or report has not been filed, a fine of ten dollars per calendar day for the first ten days after notice has been given, and one hundred dollars for each additional calendar day in which the required statement or report is not filed, not exceeding five thousand dollars.
4. Section 8-13-130 allows the Commission to “levy an enforcement or administrative fee on a person who is in violation” of the Ethics Act.

DISCUSSION

The Commission found probable cause to charge Respondent with one (1) count of violating Section 8-13-1308(A) for failing to timely file a 2019 Pre-Election CDR. Through this Consent Order, Respondent admits he failed to timely file a 2019 Pre-Election CDR. In mitigation, Respondent states that when he signed up to run for office, he was informed by local officials that he was only required to file with the Commission if he was elected.¹ Respondent further states that he was undergoing health issues that resulted in surgery when he received the Commission's certified letter in October of 2022. Respondent also states that he is a small business owner and that he accidentally double-booked himself on the day he scheduled the appointment with Non-Compliance staff. Respondent says that he subsequently neglected to contact the Commission to receive assistance. Respondent apologizes for this negligence and accepts responsibility for his failures to comply with the requirements of the Ethics Act.

DISPOSITION

1. The Commission finds Respondent in violation of one (1) count of Section 8-13-1308(A) for failing to file his 2019 Pre-Election CDR.
2. The Commission adopts the Statements of Fact, Conclusions of Law, Discussion, and Disposition as agreed upon by the Respondent.

THEREFORE, the Commission hereby issues this written warning to Respondent, and orders Respondent to pay the Commission, within six (6) months from receipt of this Order, a reduced late-filing penalty of \$500 and an administrative fee of \$300, for a total of \$800. The

¹ The Commission assumes that this was a reference to the Statement of Economic Interests, which is only required prior to taking the oath of office in non-partisan municipal elections. See Section 8-13-1356. However, as noted herein, all candidates are required to file a Pre-Election CDR fifteen (15) to twenty (20) days prior to every election, regardless of partisanship and regardless of money raised or spent.

Commission declines to assess the remaining \$4,500 in late-filing penalties.

By executing this Consent Order, Respondent understands that he is not only admitting to a violation of the Ethics Act, but also confessing to a judgment of \$800 in the event he does not make payment as provided for in this Order, in which case the Commission shall file a Judgment against Respondent with the County Clerk of Court in Respondent's last known County of residence, who shall enter this Order in the amount of \$800 (less any money paid) in its Judgment Rolls, without cost to the Commission.
