Section 8-13-1140, SC Code Ann., 1976, as amended, requires the filing of an updated Statement of Economic Interests for the previous calendar year annually thereafter prior to March 30. Records in the State Ethics Commission indicate that the Respondent was required to file the 2018 Statement of Economic Interests.

Respondent was reminded of the filing requirement by a certified letter dated February 4, 2021 as described in the attached. In addition, an email reminder was sent thirty days prior to the deadline. To date, no properly completed 2018 Statement of Economic Interests has been received. All in violation of Section 8-13-1140, SC Code Ann., 1976, as amended.

All investigations, inquiries, hearings, and accompanying documents must remain confidential unless respondent waives the right to confidentiality. If there is a finding of probable cause, the following documents become public record: the complaint, the response (if any) by respondent, and the notice of hearing. If a hearing is to be held, the final order and all exhibits become public record. If no hearing is held following a finding of probable cause, the final disposition of the matter becomes public record. The willful release of confidential information is a misdemeanor, and any person releasing such confidential information, upon conviction, must be fined not more than one thousand dollars (\$1,000) or imprisoned not more than one year. Section 8-13-320(10)(g).

Code Ann. Regs. 52-707 (1997 Cum. Supp.) on Thursday, June 16, 2022 at 9:30 a.m. at the Commission Hearing Room located at: 201 Executive Center Drive, Suite 150, Columbia, South Carolina 29210.

The following allegation will be heard:

COUNT ONE
FAILURE TO FILE STATEMENT OF ECONOMIC INTERESTS
SECTION 8-13-1140, S.C. CODE ANN., 1976, AS AMENDED

That Michael B. Parker, former Silverstreet City Council Member, did in Richland County, fail to file a 2018 Statement of Economic Interests (SEI), in violation of Section 8-13-1140.

You have the right to be represented by counsel, the right to call and examine witnesses, the right to introduce exhibits, and the right to cross-examine opposing witnesses. This hearing will be open to the public as required by Section 8-13-320(10)(j), Code of Laws, South Carolina, 1976, as amended. The procedures to be followed are set forth in the Administrative Procedures

Act, Section 1-23-10, et seq., Code of Laws, South Carolina, 1976 as amended the State Ethics Act, Section 8-13-100, et seq., Code of Laws, South Carolina, 1976, as amended, and State Ethics Commission Regulations, S.C. Code Ann. Regs. 52-707 (1997 Cum. Supp.).



BEFORE THE STATE ETHICS COMMISSION

DECISION AND ORDER

This matter comes before the State Ethics Commission (Commission) by way of a complaint filed on November 2, 2021. Pursuant to Section 8-13-320(10)(i) of the South Carolina Ethics, Government Accountability, and Campaign Reform Act of 1991 (Ethics Act), the Commission reviewed the above-captioned complaint against Michael B. Parker (Respondent) and probable cause was found to warrant an evidentiary hearing. Present at the hearing on June 16, 2022, were Commissioners Brandolyn Thomas Pinkston, Mary Hunter B. Tomlinson, and F. Xavier Starkes, Hearing Chair. Respondent was duly notified, but did not appear. Complainant was represented by Courtney M. Laster. The following charge was considered:

COUNT ONE
FAILURE TO FILE STATEMENT OF ECONOMIC INTERESTS
SECTION 8-13-1140, S.C. CODE ANN., 1976, AS AMENDED

That Michael B. Parker, former Silverstreet City Council Member, did in Richland County, fail to file a 2018 Statement of Economic Interests (SEI), in violation of Section 8-13-1140.

FINDINGS OF FACT

Having carefully reviewed the evidence presented, the Panel finds as fact:

1. At all times relevant, Respondent served as a council member of Silverstreet Town Council.
2. Respondent failed to file an annual SEI on or before March 30, 2018.
3. In a February 4, 2021, certified letter, the Commission notified Respondent of his failure to

file a 2018 SEI. According to the United States Postal Service, the letter was delivered to Respondent's address of record on February 6, 2021 at 9:20 a.m.

4. Penalties began to accrue at \$10.00 per day on February 16, 2021.
5. Penalties began to accrue at \$100.00 per day on February 26, 2021.
6. On June 15, 2021, Respondent contacted Commission staff regarding the penalty letter. Respondent was advised to submit an appeal according to the instructions contained within the penalty letter. Respondent did not submit an appeal.
7. Despite numerous attempts from Commission staff, Respondent was not in compliance as of the date of the hearing and had accrued the maximum late-filing penalty of \$5,000.00.

CONCLUSIONS OF LAW

Based upon the Findings of Fact, the Commission concludes, as a matter of law:

1. At all times relevant, Respondent was a public official pursuant to Section 8-13-100(27) of the Ethics Act. Therefore, the Commission has personal and subject matter jurisdiction.
2. Section 8-13-1140 of the Ethics Act provides, in part:

A person required to file a [SEI] under this chapter annually shall file, pursuant to Section 8-13-365, an updated statement for the previous calendar year, no later than noon on March thirtieth of each calendar year . . .

3. Section 8-13-1510(A) of the Ethics Act provides, in part:

. . . a person required to file a report or statement under this chapter who files a late statement or report or fails to file a required statement or report must be assessed a civil penalty as follows: (1) a fine of one hundred dollars if the statement or report is not filed within five days after the established deadline provided by law in this chapter; and (2) after notice has been given by certified or registered mail that a required statement or report has not been filed, a fine of ten dollars per calendar day for the first ten days after notice has been given, and one hundred dollars for each calendar day in which the required statement or report is not filed, not exceeding five thousand dollars.
6. Section 8-13-130 of the Ethics Act allows the Commission to levy an administrative fee on

any person who is found in violation of the Ethics Act.

DECISION

NOW, THEREFORE, based on the foregoing Findings of Fact and Conclusions of Law, the Panel has determined, based on a preponderance of evidence, that Respondent Michael B. Parker is in violation of one (1) count of Section 8-13-1140 for failure to timely file a 2018 SEI.


THEREFORE, Respondent is hereby Publicly Reprimanded and assessed a late-filing penalty of \$5,000.00 and an administrative fee of \$650.00, for a total of \$5,650.00.

AND, pursuant to Section 8-13-320 of the Ethics Act, if the \$5,650.00 is not paid within thirty (30) days from Respondent's receipt of this Order, a judgment in the amount of \$5,650.00 shall be entered against Respondent. In the event of a failure to pay, upon the Commission's filing of said Judgment with the Clerk of Court in the County of Respondent's last known residence, the Clerk of Court shall enter this Order in the amount of \$5,650.00 in its Judgment Rolls, without cost to the Commission.

FINALLY, Respondent Michael B. Parker, has ten (10) days from receipt of this Order to appeal this Decision and Order to the full Commission.
