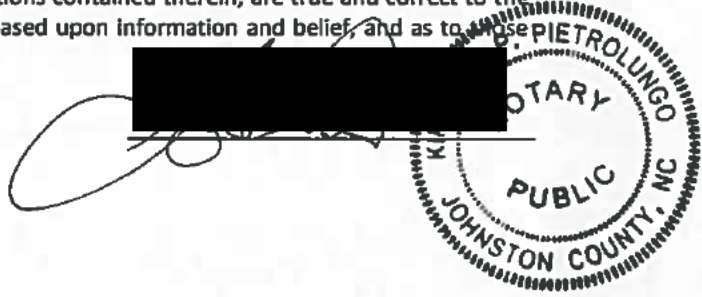

A few months ago, I discovered on followthemoney.org that Chad Price had violated Campaign and Finance rules when he made campaign contributions in his severely disabled sisters name. As her legal guardian he is tasked to care and protect her, NOT take advantage of her as he did. ***see attachment A (Disability Letter)***

Jessica Price is shown to have contributed \$17,500 to Campaigns NC, WV, GA, and KY.  
***Complaints have been filed see attachment B (Jessica's Contributions)***

While gathering facts for the complaints, the money trail of Chad Price led me to the 2018 South Carolina's Campaigns of Henry McMaster and Michael A. Wilson. Candidate disclosures were pulled, and it appears that South Carolina's Campaign Finance Rules were violated just as they were in other 2018 Campaigns in NC, WV, GA, OK, and KY.

The Campaign of Henry McMaster received \$88,500 in contributions and Michael A. Wilson's received \$101,500 in contributions from North Carolina Donors. I was astonished but not surprised that Chad Price was manipulating Campaign Finance Rules. I believed he single-handedly made most if not all the contributions using the donor's names. It appears he had a scheme where he would flood money to a specific group of Candidates in the 2017/2018 Campaigns. After looking at his contribution history it was obvious to me that he targets politicians that play a key role in state government. Elected officials that he or his company could benefit from in some way.

As his father, I know he is motivated and driven by money, power and success. Perhaps one of the many reasons we have not spoken in years. As his parents we should be very proud of his success with his company, MAKO Medical. All the praise, accolades and awards he receives. Quite the opposite, we are ashamed of what he has done. His priorities are in the wrong place, one cannot go through life deceiving others and playing people as fools.

***"Better is a Poor Man who walks in his integrity than a Rich Man who is crooked in his ways....."***

Chad has set a pattern in this Campaign and others. Many of the same NC donors are repeatedly used to make contributions. Many contributions were made on the same day or grouped on same days. Contributions on all the disclosures are all for the same maximum state limit, which varies from state to state. There was one \$1000 contribution to Henry McMaster's Campaign from the committee to elect Dan Forest. Chad Price has fundraised for Dan Forest, did he take it upon himself to use the committee's name to make this contribution? Did the committee approve it? Are they even aware?

Chad lives at 966 Tender Dr., Apex NC with his sister, Jessica. He also has a rental property at 1008 Sumac Ct., Clayton NC and his company, MAKO Medical is located at 8461 Garvey Dr., Raleigh, NC. *(Chad Price and Josh Arant are co-founders of MAKO Medical Laboratory, a Raleigh NC company with expansions in 10-states)* All three addresses are used frequently for donors on many disclosures, when in fact they have their own address. It appears it is an attempt to conceal the truth, or just plain Deception from Chad. If a donor makes their own contribution, they are going to know their own address and not use one of the addresses above. When this occurs, as it does quite frequently it raises flag and tells me one thing, they did not make their own contribution.

Donor histories tell a lot, except for Chad Price, Jerry/Jim and Stephanie Bynum, None of the Donors have ever made campaign contributions prior to 2017/2018.

Attached are filtered disclosures from Henry McMaster and Michael A. Wilson's 2017/2018 Campaigns. Issues and concerns that are questionable are identified in RED.

Attached are NC Contribution Histories from Chad Price, which includes contributions he made in his brother's name, Adam Price and in his sister's name, Jessica Price.

Attached are NC Contribution Histories of the Bynum's. Jerry Bynum is a close friend of Chad Price, in fact Chad worked for Jerry at a business he owned prior to MAKO medical.  
***Note: The address of 966 Tender Dr., Apex NC is used for contributions from Jim, Jerry, Nanza and Stephanie Bynum. Also Note: The drastic increase in contribution amounts in***

2017/2018 compared to previous. Reason to believe Chad Price made the transactions and funded contributions. **see attachment H (Bynum Family Filtered NC Contributions)**

Attached are 2017/2018 Campaign Candidate disclosures from WV, GA, KY, and OK, for comparison. *Note: KY Disclosure of Stephan Knipper shows Chad Price made three contributions for \$2000, his, Jessica's and Adam's. He falsifies disclosure information showing Jessica's as a housewife and married to her younger brother, Adam Price. He also shows his younger brother Adam as Vice President of MAKO Medical and Jessica as his spouse. Chad Price willfully and knowingly deceived KY Campaign Finance and got away with then. After my discovery I reported it as illegal contributions. see attachments: I, J, K, L (WV, GA, KY, and OK 2017/2018 Campaign Disclosures)*

### **Issues commonly seen on candidate disclosures that raise many questions**

- All Donors are from NC, except for two donors from WV (*whom both are MAKO Employees*)
- All Contributions by all donors were always at maximum state limits for each Campaign
- Contributions *were all* for the same amount from each donor in all Campaigns
- Contributions were made on the same day, or grouped on same day in all Campaigns
- Many of the same donor names were used repeatedly in 2017/2018 Campaigns
- Information was not consistent, i.e. addresses, employers, and occupations
- Address of 966 Tender Dr., Apex NC (address of Chad Price) used for donors
- Address of 8461 Garvey Dr., Raleigh, NC (address of MAKO Medical) used for donors
- All Donors have an association to Chad Price and or MAKO Medical
- In WV Campaigns, names of donors were fictitious (*made-up*) and Chad Price uses alias
- Jim and Jerry Bynum appear on many disclosures (*both are the same person*)
- LLC's were all from NC, but "only" used in South Carolina Campaigns
- LLC's were dissolved prior to contributions
- LLC's could not be found in NC Secretary of State, Business Search data base
- Donor Histories, except for Chad Price, Jerry/Jim and Stephanie Bynum "NONE" had any history of making Campaign Contributions prior to 2017/2018

All donors have something in common to Chad Price and his business. *All* are either family, friends, business associates or employees of MAKO Medical. I believe Chad Price took it upon himself to funnel thousands of dollars through donors to multiple campaigns. I believe donors may not even be aware of contributions that were made. If they were aware, I strongly believe Chad Price funded *many if not* all the contributions. *The truth will be revealed during your inquiry.*

Chad Price's brazen disregard for the law led him to deceive and manipulate a system that is vulnerable. I believe he took full advantage of it with little fear of ever being caught. Campaign Finance and Campaign Treasurers cannot scrutinize every contribution. There are just too many errors that are too easy to find. It is "No" coincidence that contributions were on the same day. *Same day contributions appear on many of the disclosures.*

Lets' be honest, what do *any* of the NC Donors hope to gain by contributing to Henry McMaster's and or Michael A. Wilson's Campaigns? **Nothing at all**, only Chad Price / MAKO Medical does.

**South Carolinians should be confident that elections are not being influenced by illegal campaign contributions. Campaign finance laws give transparency to political contributions and protect the public's ability to see who's really funding a campaign. Those who undermine this process and use it to gain power and influence must be held accountable. No one is exempt, laws are written to obey. I believe Chad Price caused Campaign Treasurers to file inaccurate Campaign Finance Reports unknowingly to them in WV, GA, OK, KY and SC. The power of the purse wins elections. Contributions to Candidates are important and welcomed, but they must be legitimate.**

**To Whom It May Concern:**

I have been caring for Jessica Price for the past year as her pediatrician. She suffers from a rarely survivable genetic disorder called Trisomy 16. Most individuals with this disease are stillbirths or die in early infancy. Survivors are moderately to severely mentally retarded and require the interventions of multiple special services just to meet the basic needs of every day living (occupation, speech, and physical therapy as well as special education). Over the years these services have been well provided by her parents.

Now that Jessica is 19 years of age, it is important that her rights and needs continue to be addressed. Though she is an adult by chronological age, her comprehension and self-care skills remain those of a 3 - 4 year old. Multiple evaluations of Jessica reveal an IQ range of 30 to 41. She cannot live independently and cannot make informed decisions regarding her own health. This is a static condition and currently no available medical intervention can be expected to result in improvement in Jessica's capabilities.

For this reason, I am suggesting that a guardian be appointed to provide for her care for the foreseeable future. It would also seem prudent to make financial provisions for her needs in the event that her parents predecease Jessica. Please contact me if there are questions or concerns about this individual's care.

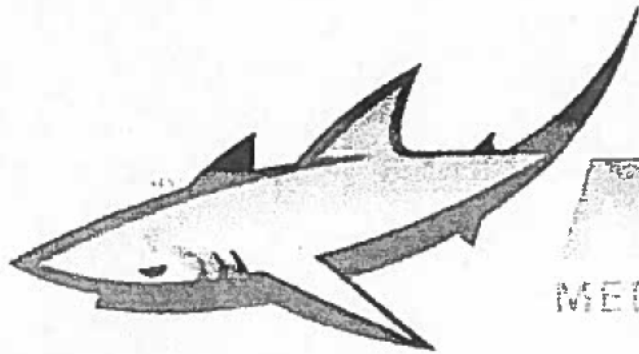

**CONSENT ORDER**

This matter comes before the State Ethics Commission (Commission) by way of a Complaint filed on July 17, 2019. Pursuant to Section 8-13-320(10)(i) of the South Carolina Ethics, Government Accountability, and Campaign Reform Act (Ethics Act), the Complaint against Chad E. Price (Respondent) was considered by the Commission and probable cause was found to warrant an evidentiary hearing on fifteen (15) violations of Section 8-13-1314 for making excessive contributions as described herein. Prior to the call of the case, Respondent agreed to entry of the following:

**STATEMENTS OF FACT**

1. In 2018, Henry McMaster (McMaster) was a candidate for South Carolina Governor. McMaster participated in a primary election on June 12, 2018, a primary runoff election on June 26, 2018, and a general election on November 6, 2018.
2. In 2018, Alan Wilson (Wilson) was a candidate for South Carolina Attorney General. Wilson participated in a primary election on June 12, 2018, a primary runoff election on June 26, 2018, and a general election on November 6, 2018.
3. Respondent made the following contributions in his own name to the campaigns of McMaster and Wilson leading up to the 2018 primaries, run-offs, and general elections:

<sup>1</sup> During the Commission investigation, Commission Investigators found that “Raleigh Tune & Lube” and “Raleigh Tune & Lube/Speedee Oil” were the same corporation. On February 14, 2020, based on information obtained from the Commission, the McMaster campaign refunded \$3,500.00 to the credit card used to make these contributions, which belonged to Respondent. Subsequently, Commission Investigators obtained Respondent’s bank records, which revealed all of the contributions enumerated in Paragraph Four (4) derived from the same credit card. Since that time, the McMaster and Wilson campaigns have refunded each of the contributions enumerated in Paragraph Four (4).

5. Respondent initially maintained through counsel that he had recouped the funds he used to make these contributions through regular distributions from the corporations - an indirect reimbursement. However, Respondent subsequently admitted through counsel that no actual direct reimbursements occurred. Respondent further admitted, and the Commission investigation confirmed, that all the above-referenced contributions were made from his personal credit card.
6. The Complaint filed against Respondent alleged that Respondent improperly contributed to the Wilson and McMaster campaigns. Aside from the charges discussed herein, the Commission did not find sufficient evidence to support the remaining allegations in the Complaint.

#### CONCLUSIONS OF LAW

Based upon the Statements of Fact, the Commission concludes, as a matter of law:

1. Section 8-13-1300(25) defines "person" as:

an individual, a proprietorship, firm, partnership, joint venture, joint stock company, syndicate, business trust, an estate, a company, committee, an association, a corporation, club, labor organization, or any other organization or group of persons acting in concert.

2. At all times relevant, Respondent was a person contributing to candidates in South Carolina elections pursuant to Section 8-13-1300(25). Therefore, the Commission has personal and subject matter jurisdiction.

3. Section 8-13-1300(7) defines "contribution," in relevant part, as:

a gift, subscription, loan, guarantee upon which collection is made, forgiveness of a loan, an advance, in-kind contribution or expenditure, a deposit of money, or anything of value made to a candidate or committee to influence an election; or payment or compensation for the personal service of another person which is rendered for any purpose to a candidate or committee without charge, whether any of the above are made or offered directly or indirectly.

4. Section 8-13-1300(10) defines "election cycle" as:

the period of a term of office beginning on the day after the general election for the office, up to and including the following general election for the same office, including a primary, special primary, or special election; however, the contribution limits under Section 8-13-1314 and 8-13-1316 apply only to elections occurring on or after January 1, 1992, and are for each primary, runoff, or special election in which a candidate has opposition and for each general election. If the candidate remains unopposed during an election cycle, one contribution limit shall apply.

5. Section 8-13-1314 provides, in relevant part:

(A) Within an election cycle, a candidate or anyone acting on his behalf shall not solicit or accept, and a person shall not give or offer to give to a candidate or person acting on the candidate's behalf:

(1) a contribution which exceeds:

(a) three thousand five hundred dollars in the case of a candidate for statewide office; or

(b) three thousand five hundred dollars in the aggregate for statewide candidates elected jointly pursuant to Section 8, Article IV of the South Carolina Constitution, 1895; or

(c) one thousand dollars in the case of a candidate for any other office;

#### **DISCUSSION**

The Commission found probable cause to charge Respondent with fifteen (15) counts of violating

Section 8-13-1314 for making the following excessive contributions:

- (1) \$3,500.00 to the McMaster Primary Election Cycle on July 1, 2017, in the name of Raleigh Tune & Lube/Speedee Oil;
- (2) \$3,500.00 to the McMaster Primary Election Cycle on July 1, 2017, in the name of Sans Pariel, LLC;
- (3) \$3,500.00 to the McMaster Primary Election Cycle on July 1, 2017, in the name of Element Service Group, LLC;
- (4) \$3,500.00 to the McMaster Primary Election Cycle on October 1, 2017, in the name of Raleigh Tune & Lube;
- (5) \$3,500.00 to the McMaster Primary Runoff Election Cycle on June 25, 2018, in the name of Element Service Group, LLC;
- (6) \$3,500.00 to the Wilson Primary Election Cycle on December 7, 2017, in the name of Mako Medical Laboratories, LLC;
- (7) \$3,500.00 to the Wilson Primary Election Cycle on December 7, 2017, in the name of Mako Genomics, LLC;
- (8) \$3,500.00 to the Wilson Primary Election Cycle on December 7, 2017, in the name of Element Service Group, LLC;
- (9) \$3,500.00 to the Wilson Primary Election Cycle on December 7, 2017, in the name of Bynum Properties 3, LLC;
- (10) \$3,500.00 to the Wilson Primary Election Cycle on December 7, 2017, in the name of Raleigh Tune & Lube II, Inc.;
- (11) \$3,500.00 to the Wilson Primary Runoff Election Cycle on June 26, 2018, in the name of Sans Pariel, LLC;
- (12) \$3,500.00 to the Wilson General Election Cycle on October 23, 2018, in the name of Element Service Group, LLC;
- (13) \$3,500.00 to the Wilson General Election Cycle on October 23, 2018, in the name of Mako Medical Laboratories, LLC;
- (14) \$3,500.00 to the Wilson General Election Cycle on October 23, 2018, in the name of Mako Genomics, LLC; and
- (15) \$3,500.00 to the Wilson General Election Cycle on October 23, 2018, in the name of Bynum Properties 3, LLC.

Within an election cycle, a person is entitled to contribute up to \$3,500.00 to a statewide candidate

such as Governor or Attorney General. For purposes of computing contribution limits, two separately incorporated corporations are different “persons” when they have distinct and separate business purposes. See SEC AO95-005 (November 16, 1994). However, in this case, the corporations did not make the contributions—Respondent did, using his own personal credit card for each contribution. Through this Consent Order, Respondent acknowledges he violated the Ethics Act when he made each of these fifteen (15) contributions. In mitigation, Respondent states that he spoke with “Rebecca,” a representative from the Wilson campaign in or around the time of the aforementioned contributions. According to Respondent, Rebecca informed him that it was permissible for each corporation to make a separate contribution.<sup>2</sup> From that, Respondent inferred that the method he made the contributions was permissible.

#### DISPOSITION

1. The Commission hereby finds Respondent in violation of fifteen (15) counts of Section 8-13-1314.
2. The Commission hereby adopts the Statements of Fact, Conclusions of Law, Discussion, and Disposition as agreed upon by the Respondent.

THEREFORE, the Commission hereby orders the Respondent to pay the Commission, within sixty (60) days from receipt of this Order, a reduced civil penalty of twenty thousand dollars (\$20,000.00) and an administrative fee of five thousand dollars (\$5,000.00), for a total of twenty-five thousand dollars (\$25,000.00). The Commission notes that the total possible civil penalty in this matter is \$30,000.00 (\$2,000.00 for each violation). However, the Commission declines to assess the remaining \$10,000.00 in light of Respondent’s conversation with the Wilson campaign regarding some of the contributions.

By executing this Consent Order, Respondent understands that he is not only admitting to violations of the Ethics Act, but also confessing to a judgment of twenty-five thousand dollars (\$25,000.00) (less any

money paid to the Commission) in the event he does not make full and timely payment as provided for in this Order. In that event, the Commission shall file a Judgment against Respondent with the Clerk of Court in the County of Respondent's last known residence. Upon said filing, the Clerk of Court shall enter this Order in the amount of twenty-five thousand dollars (\$25,000.00) (less any money paid to the Commission) in its Judgment Rolls, without cost to the Commission.
