CREATE A USER ACCOUNT

In order to file Campaign Disclosure forms, Operating Disclosure forms, Statements of Economic Interests and Statements of Organization, a user account must be created. Creating a user account will prevent you from having to enter demographic and similar data multiple times when filing for the same office or election year.

If

- (1) you have filed a non-electronic Campaign Disclosure form, Operating Disclosure form, Statement of Economic Interests or Statement of Organization for this campaign after January 2008 AND
- (2) you are not a Legislative Caucus AND
- (3) you are not a State House Representative or State Senator,

then the State Ethics Commission has already created an account for you using an administrative email address.

Please contact the State Ethics Commission for your Username and Password. The email address associated with your account must be updated. The State Ethics Commission can do this at this time or you can login (see page 21) to your account with the username and password provided by the State Ethics Commission and update your email address. Once your email address is updated you will be able to change your password.

Click on “create a user account”,

- If you have not previously registered and need to file a Campaign Disclosure, Operating Disclosure, Statement of Economic Interests or Statement of Organization.
- If you already have a user account but need to file a new Campaign Disclosure form, Operating Disclosure form, or Statement of Organization for a **different** office/position.
- If you have **already filed a final report** for your current office/position and you need to submit a new filing.

Legislative caucuses and political parties need to register an account to file a Non-Candidate Campaign Disclosure and another account to file an Operating Disclosure.

You do not need to create a new user account if

- You need to add a position to your Statement of Economic Interests. You will need to login and amend your currently filed Statement of Economic Interest.
- Your office/position has not changed but you need to file for a new campaign period. You will need to login and start filing for a new campaign.

3. **Please enter your email address.**

The Administrator will have limited access to account usernames. An email address is required for the purpose of account management and to receive notices from the State Ethics Commission. By registering for an account you acknowledge the acceptance of notification emails from the State Ethics Commission regarding report filing and reporting deadlines.

Step 3 - Enter your email address in the space provided. When you file a report, an email confirmation will be sent to this email account. Some email providers may prevent these confirmations from appearing in your inbox or may not allow you to receive the confirmation at all. Please be sure to check Junk, Spam or Bulk mail folders. It is known that filing confirmations are not being received by hotmail or email.com email accounts. It is suggested that you do not register with a hotmail email account.

Step 4 - Click “Next” to continue creating your account.

The State Ethics Commission, State House Ethics Committee and State Senate Ethics Committees have limited access to account usernames in the event that you cannot recall your username, password and email address used to register your account.


